This document provides a description of the technical enhancements to the EDEN Submission System (ESS) version 3.6 released September 11, 2007. Later updates made in late September and October 2007 are also included in this document.

Revisions to the document include system changes that were implemented in subsequent System Change Requests (SCRs).

EDEN is a centralized, coordinated repository of state reported, K through 12, educational data residing at the U.S. Department of Education. The EDEN Submission System is an electronic system that facilitates the efficient and timely transmission of data from SEAs to the U.S. Department of Education.

## 1.0 PURPOSE

The purpose of this document is to educate the users of the EDEN Submission System about the improvements that have been made to the system and to provide guidance to users on issues that they may encounter with the new software release.

This document lists all system enhancements and documentation updates that were implemented with the ESS Release 3.6. The majority of the enhancements include support for ongoing enhancements and maintenance of the ESS.

Where applicable, items are prefixed with corresponding trouble ticket information. For example, "TT 233" refers to the trouble ticket opened by the software development team. "PSC 05-00367" refers to the ticket number opened by the Partner Support Center.

## 2.0 SUMMARY OF IMPROVEMENTS (RELEASE 3.6)

### 2.1 ESS Application Updates

ESS Release 3.6 (September 11, 2007) includes the following new system functionality:

- 1) New ESS business rules were implemented to reflect OSEP/DANS edit logic. 21 new edits related to specifications N/X005, 006, 070, 088, and 099 were implemented to create greater stringency and ensure that high quality data is accepted by ESS. Details are provided in Appendix A.

A subset of OSEP/DANS edits were not included in ESS 3.6 due to uncertainty around the required edit logic. Edits for specs N/X002, 089, and 112 have been deferred to ESS 4.0 scheduled for release in December 2007. One edit for N/X007 has been deferred to 4.0 as well due to an inability to test the requested edit until SY 2007-08 files are made available to conduct the test.

## 3.0 SUMMARY OF IMPROVEMENTS (RELEASE 3.6A)

### 3.1 ESS Application Updates

ESS Release 3.6a (September 18, 2007) includes the following new system functionality:

- 1) TT 1744; PSC 07-43473: The system was updated to avoid displaying missing errors on the Verify Missing tab of the School Edit Report as long as a number of 0 (zero) or greater is submitted for the count.

- 2) The latest version of the ESS Frequently Asked Questions v3.2 was posted on [www.ED.gov](http://www.ED.gov).

## 4.0 SUMMARY OF IMPROVEMENTS (RELEASE 3.6B)

### 4.1 ESS Application Updates

ESS Release 3.6b (September 25, 2007) includes the following new system functionality:

- 1) TT 1753; PSC 07-43524: The system was updated to allow a state to submit a carriage return/line feed within the File Identifier field in the header record. This corrects a server error that was generated when any state submits a school directory file with an extra cell.
- 2) TT 1768; PSC 07-43703: The system was updated to add a validation edit to check the length of the Address fields and generate an error if the length of the data is too long.
- 3) TT 1776; PSC 07-43795: The system was updated to correct errors that were appearing on the school tab of the Match Summary report indicating that a new agency had schools that were not new.

## 6.0 SUMMARY OF IMPROVEMENTS (RELEASE 3.6D)

### 6.1 ESS Application Updates

ESS Release 3.6d (October 19, 2007) includes the following new system functionality:

- 1) TT 1813; PSC 07-44230: The system was updated to accept the File Type description for a file due to an error caused by a difference in the spelling of the word "Intersession" in ESS and the file specification N/X124.
- 2) TT 1838; PSC 07-44418: Validation errors were incorrectly being generated due to the system conducting a mandatory validation for file specification N102 on

fields considered optional. The system was updated to not require the optional field.

## 7.0 SUMMARY OF IMPROVEMENTS (RELEASE 3.6E)

### 7.1 ESS Application Updates

ESS Release 3.6e (October 23, 2007) includes the following new system functionality:

- 2) TT 1847; PSC 07-44503: The File Identifier was incorrectly replaced with the number of characters in the identifier instead of the actual contents. This occurred when the Transmittal Status Report default view was sorted by the State, File Identifier, Transmittal File Name, File Type, or Transmittal Status columns. The field was returning the character length instead of the actual value possibly due to testing purposes. The system was updated to return the actual value.
- 3) TT 1848; PSC 07-44524: When viewing Directory Information for Alabama LEA "Three Springs Madison Sch" in ESS a system error was received. The error message appeared in the Transmittal Status report and the Education Unit Profile due to a single quote in the AdressLine1, which caused the SQL to fail. The stored procedure was modified to escape the quote enabling the system to handle single quotes.

## 8.0 SUMMARY OF IMPROVEMENTS (RELEASE 3.6F)

### 8.1 ESS Application Updates

ESS Release 3.6f (October 30, 2007) includes the following new system functionality:

- 1) TT 1853; PSC 07-44585: The “State Agency Reviewer” role did not have access to the Submission Error Report. It was determined access should be given to this role. The system was updated to give access to this role.
- 2) TT 1854; PSC 07-44573: Florida received several errors caused by Business Rule S009-R04. According to the *EDFacts* Business Rules Guide, this error should not have required corrective action and should appear on the Warnings Tab. The system was updated to show the business rule as a warning on the Warnings Tab.
- 3) TT 1856; PSC 07-44626: PSC had an issue when using the “All States” state in ESS. The state drop down in the Education Unit Profile did not populate. A stored procedure was failing when populating the state dropdown in the Education Unit Profile because a temporary table within the stored procedure used the incorrect data type. This stored procedure was updated to handle all FIPSSStateCode records regardless of data type.
