Dear Director Stone:

We have approved Arkansas' grant application for Federal fiscal year (FFY) 2021 funds, under Part C of the Individuals with Disabilities Education Act (IDEA Part C). Our approval is based on our review of the IDEA Part C grant application, submitted by the Arkansas Department of Human Services (ADHS) to the U.S. Department of Education (Department), Office of Special Education Programs (OSEP), on May 5, 2021, June 16, 2021, and June 24, 2021.

Our approval of the State's FFY 2021 IDEA Part C grant application includes approval of policies, procedures, methods, descriptions, assurances, and certifications identified in Section II.A, II.B, and II.C, which is incorporated by reference to this grant award letter as Enclosure A. Our approval is also based on the State's certification in Section II.D of its FFY 2021 IDEA Part C grant application, signed by you on June 24, 2021, that the State's provisions meet the requirements of IDEA Part C as found in 20 U.S.C. §§ 1431 through 1443 and the regulations in 34 C.F.R. Part 303, and that the State will operate its Part C program in accordance with all of the IDEA Part C requirements including required policies, procedures, methods, descriptions, assurances and certifications. See, 34 C.F.R. § 76.104.

Enclosed are two separate grant award notification (GAN) documents. The first GAN represents the State's FFY 2021 IDEA Part C grant award for funds currently available under the Consolidated Appropriations Act, 2021 (Public Law 116-260) (CAA). The second GAN represents the State's grant award for IDEA Part C funds under Section 2014 of the American Rescue Plan (ARP). Both grant awards are subject to all the terms and conditions of the State's FFY 2021 IDEA Part C grant application. The funds under both of these grant awards are available for obligation by States from the effective date of the grant award, July 1, 2021 through September 30, 2023, in accordance with 34 C.F.R. § 76.709.

Each State submitted its Section III – Use of Funds for its CAA FFY 2021 funds and must submit by August 2, 2021, a separate Section III – Use of Funds to reflect the total allocation for its ARP IDEA Part C funds. OSEP looks forward to receiving the Section III for the ARP IDEA Part C funds. Once the awards are made, States may need to amend these Section III documents under 2 C.F.R. § 200.308. The requirements for Section III amendments are discussed in Section 4 of OSEP Memo 21-02 IDEA Part C FFY 2021 Grant Application Procedures.

Under IDEA Section 605, and 2 C.F.R. Part 200, and 34 C.F.R. § 303.104, States must obtain prior approval to charge certain expenses as direct costs. On October 29, 2019, the Office of

## Page 2 - Lead Agency Director

Special Education and Rehabilitative Services (OSERS) released a Frequently Asked Questions (2019 FAQs) document on prior approval.<sup>1</sup> In the event the State identified such costs in Section III of its application for costs not covered by the 2019 FAQs, OSEP will respond to any prior approval requests under separate cover. OSEP's approval of the FFY 2021 IDEA Part C grant application does not constitute approval for such costs. Please contact your OSEP State Lead for further assistance.

Section IV.B of the IDEA Part C FFY 2021 application requested updated information about how your lead agency implements the restricted indirect cost rate requirements in 34 CFR §303.225(c). Your State indicated in Section IV.B that ADHS has a cost allocation plan that was approved by your cognizant Federal agency. Under IDEA Part C, the Department must ensure that the State lead agency's cost allocation plan meets the nonsupplanting requirements in IDEA section 637(b)(5)(B) and restricted indirect cost requirements in 2 CFR §200.210(a)(15) and 34 CFR §303.225(c). Approval of the State's IDEA Part C FFY 2021 grant application is not an indication that the State's cost allocation plan meets these nonsupplanting and restricted indirect cost requirements. OSEP and the Department's Indirect Cost Division will work with the State and its cognizant Federal agency to ensure that its cost allocation plan meets the applicable restricted indirect cost requirements. Under 2 CFR §200.210(a)(15), by accepting these IDEA Part C grant awards, your State lead agency is agreeing to charge indirect costs on a restricted basis for the period that the State uses any funds awarded under its FFY 2021 CAA IDEA Part C and ARP IDEA Part C grant awards.

Section 604 of the IDEA provides that "[a] State shall not be immune under the 11<sup>th</sup> amendment to the Constitution of the United States from suit in Federal court for a violation of this [Act]." Section 606 provides that each recipient of assistance under IDEA make positive efforts to employ and advance in employment qualified individuals with disabilities in programs assisted under the IDEA. Therefore, by accepting this grant, your State is expressly agreeing as a condition of IDEA funding to a waiver of Eleventh Amendment immunity and to ensuring that positive efforts are made to employ and advance employment of qualified individuals with disabilities in programs assisted under the IDEA.

The enclosed grant awards are made with the continued understanding that this Office may, from time to time, require clarification of information within your application, if necessary. These inquiries may be necessary to allow us to appropriately carry out our administrative responsibilities related to IDEA Part C.

If your State revises those IDEA Part C policies or procedures that are required under Part C of the IDEA or the regulations in 34 C.F.R. Part 303, the State must subject those policies and procedures to the public participation requirements in 34 C.F.R. § 303.208 and receive OSEP approval for those policies and procedures referenced in 34 C.F.R. § 303.101(c) prior to their implementation.

Under the 2019 FAQs, OSERS granted prior approval for participant support costs under IDEA that: are associated with State Interagency Coordinating Councils; incurred during the provision of services under IDEA; do not exceed \$5000 per individual participant per training/conference. In addition, the 2019 FAQs provide prior approval for equipment that is identified on or directly related to the implementation of the IFSP.

As a reminder, all prime recipients of IDEA (Part B or Part C) funds, must report subaward information as required by the Federal Funding Accountability and Transparency Act of 2006 (FFATA), as amended in 2008. First-tier subaward information must be reported by the end of the following month from when the award was made or obligated. FFATA guidance is found at <u>https://www.fsrs.gov/</u>.
