## **Recent Grantee Communications**

**Sent 11/21/24 – ARP ESSER State Plan Amendment Update:** Grantees received a communication to inform them they are no longer required to submit amendments to their ARP ESSER State Plan as the period of availability of ARP ESSER funds ended on 9/30/24. The Department will use ARP ESSER data to monitor State spending of SEA Reserve funds and will continue to support States in maximizing their use of remaining funds. **Link:** [State Plan Amendment Update 11/21/24](#)

**Sent 11/13/24 – Implementation of Approved Consolidated Administrative Funds Tydings Waivers:** Grantees received a communication addressing questions the Department has received about the implementation of the consolidated administrative funds Tydings waivers and the liquidation of ARP funds.
