Dear Superintendent Hayashi:

We are writing regarding the Hawaii Department of Education's (HIDOE's) percentage of students taking the alternate assessment based on alternate academic achievement standards (AA-AAAS). The Elementary and Secondary Education Act of 1965 (ESEA) limits the percentage of students that a State may assess with an AA-AAAS to no more than 1.0 percent of all assessed students in reading/language arts, mathematics, and science.

The U.S. Department of Education (Department) recognizes that this was a new requirement starting in the 2017-2018 school year and that most States previously assessed more than 1.0 percent of students with the AA-AAAS. We further understand that States needed time to adjust their systems to reduce AA-AAAS participation rates and that the COVID-19 pandemic impacted many plans in States in the 2019-2020 and 2020-2021 school years.

For the 2021-2022 school year, HIDOE submitted information to the Department via *EDFacts* that showed the following AA-AAAS rates:

**Reading/language arts:** 0.97%      **Mathematics:** 0.96%      **Science:** 1.02%

Let us start by congratulating HIDOE for being below 1.0 percent in reading/language arts and mathematics, which is an important accomplishment. Because HIDOE had a rate of AA-AAAS participation greater than 1.0 percent in science and had an assessment participation rate that was less than 95 percent for all students in science and less than 95 percent for students with disabilities in science, the Department is requesting that the State submit a plan for reducing the rate of AA-AAAS participation in future years in order to meet the 1.0 percent requirement. Please submit this plan by email to the Department at [ESEA.Assessment@ed.gov](mailto:ESEA.Assessment@ed.gov) within 30 calendar days of the date of this letter.

If the State continues to have an AA-AAAS participation rate over 1.0 percent in future years, the Department may take additional action. This is particularly true if the State is unable to demonstrate that it is making progress reducing the percentage of students taking the AA-AAAS.
