**ESSER Year 4 (FY23) Annual Performance Reporting (APR) Data Collection Now Open:** The Elementary and Secondary School Emergency Relief (ESSER) Fund Year 4 (FY23) Annual Performance Report (APR) data collection opened today, Monday, May 13, 2024, and will close at 8 pm ET, on Thursday, June 6, 2024. If you do not see your ESSER Year 4 (FY23) APR once you are logged into the ESF Data Collection Tool, manually refresh your page by selecting *Ctrl + F5* or select the *Application Updated – Click here or reload page for latest version* link at the top of the page, if available. Reminder: Business rules will be applied to your data. The U.S. Department of Education strongly encourages you to start the APR data input process early to be able to resolve business rule errors in a timely manner. All data collection periods close at 8pm ET on the last day of the scheduled data collection window. The APR User Guide is available on the [ESF Grantee Help](#) page. **ESF Business Rule Validation with File Checker:** The File Checker tool allows SEAs to verify that reporting templates pass all business and formatting rules required for submission prior to opening the Annual Performance Reporting (APR) data collection tool. Once logged into the data collection tool, make sure to refresh the page either by selecting the “refresh” prompt that may be located at the top of the page, or select *Ctrl+F5* to manually refresh the page. Click the *Preview* button, which appears next to the ESSER FY 2023 (Year 4) APR on the ESF Reporting landing page, to access the File Checker tool.
